| 30 March 2016 | Re-Trial Hearing – County Court (sitting at Melbourne) Indictment severed into 3 trials complainants (TB, RC & KP) Trial involving RC – 18 charges |
| 10 May 2016 | Jury returned verdict of guilty to all charges involving RC Note – jury return verdicts of not guilty to separate indictments involving TB & KP |


