30 Aug 2006	On the first day of hearing of the Earlier Proceedings, Ayoub's lawyers communicated to Lepore and Conomos an offer to settle the Earlier Porceedings for \$600,000 plus costs ("the Settlement Offer"). Lepore and Conomos did not communicate the Settlement Offer to Kendirjian but merely of the fact that an offer had been made. Lepore and Conomos rejected the Settlement Offer absent any instructions from Kendirjian on the basis that it was "too low".	
13 Oct 2006	Delaney DCJ delivered judgment awarding Kendirjian \$308,432.75 damages.
