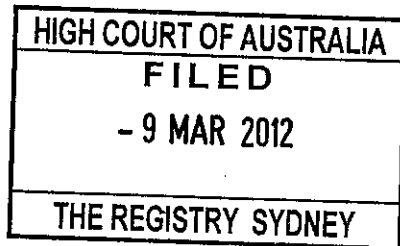

21.07.2004	The Company purports to redeem Hedy's 8 "C" class shares for \$8.00.	
15.05.2007	Ami, Tami and John Halliday are appointed executors of Hedy's estate.	
05.06.2007	Tami commences proceedings in the Supreme Court of New South Wales by filing of statement of claim.	
03.10.2008	Statement of claim amended to join the Company as a party, and seek orders against it, including declarations that the 8 "C" class shares were not "redeemable preference shares" and associated relief.	
16.09.2010	<p>Consent Orders made in relation to various issues in dispute (but not concerning the status of the 8 "C" class shares).</p> <p>Pursuant to those consent orders, Michael Henley assumes the role of the administrator of the estates of Leo and Hedy.</p>	
17.09.2010	Hamilton AJ delivers judgment and makes the declarations sought in the amended statement of claim.	
17.08.2011	Appeal to the Court of Appeal of the Supreme Court of New South Wales allowed.	
10.02.2012	Special leave to appeal granted by the High Court of Australia.	
24.02.2012	Notice of Appeal filed in the High Court of Australia.
